## Minutes of the Regular Meeting Board of Trustees Village of Forreston Monday, February 19, 2018

Building, Grounds, Parks, Zoning, and Planning Committee set a meeting for February 26<sup>th</sup> at 6:30 PM to discuss the FY2018-19 budget year.

A Law Enforcement Update from Police Chief Mike Boomgarden is reviewed for activity from February 6, 2017 through February 19, 2017.

Superintendent of Public Works Alan Cruthis gives a report of his department from February 5, 2017 through February 19, 2017.

Jerry Funk from WIPFLI gives a brief presentation on the audit for FY2016-17. He explains the different sections of the audit and states there was a clean opinion given.
