Department Reports:

Supt. of Public Works Report – Maintenance Supervisor Timm reviewed his report. He stated brush pickup has continued. They cold patched alleys and streets and changed oil in clarifier. They made brackets and jacked up the shelter house at Memorial Park. They changed the oil in the leaf vac and put up the payment drop box at Village Hall. They trimmed trees around town and pulled the aerators up in WWTP ponds and cleaned them. They also cored out and graveled an alley. They put the leaf box on and will be starting to pick up leaves this Friday. Supervisor Timm stated Brian passed his written CDL test and will be getting signed up to take the driving test part next.

Chief of Police Report – Chief Thiel stated officers responded to Casey's for a report of a car versus structure. A male with a medical disability had accidentally accelerated instead of breaking. Officers are continuing investigation on a felony theft case. They also responded to a car versus truck accident at the intersection of Main Street and Walnut Avenue. Officers were able to retrieve video footage of the incident. Chief Thiel stated shop with a cop will be on December 2, 2023. He also stated he is working on a grant for body cameras that will be mandatory by December 31, 2024. Trustee Buss asked where we are at with enforcing the dumpster ordinance. Chief Thiel stated officers handed out the ordinance to everyone in town with a dumpster. We will give everyone time to coordinate with the garbage companies.

Clerk's Report – Clerk Shenberger stated she will be meeting with Treasurer Schneiderman next week to go over some questionnaires for Gworks to move to the next step.

Committee Reports:

Streets & Alleys - Trustee Buss - Nothing to report.

Sewer and Water – Trustee Vinnedge stated he spoke with Dan Pepin on Friday, and he said we want to cancel the contract with WinWater we can. We would have to start over with the bidding process if that is what we decide to do. We will have to get Rob involved. The board is in agreement with canceling the contract.

Finance - Trustee Busker is absent.

Buildings, Grounds, Parks, Zoning, Planning - Trustee Cotter stated the parks will be getting closed down soon. We will be getting ready for Christmas in the Country soon. He stated we will be getting some new lights for the trees at Memorial Park.

Ordinances – Trustee Norris stated she has been in the office working on sending the minutes for codification and has completed ten years.

Village President's Report – President Metzger stated he was in contact with Jillian Slick on the railing. We should be getting it sometime this week then it will need to be painted before it gets installed. There are also a couple of loose bricks there that will be taken care of when the railing is installed.

Unfinished Business – Railroad property behind Smokin Gun Worx – Trustee Norris is going to talk to Rob to get the paperwork going. He will work with Seth at Fehr Graham to get it divided out and then will get us a resolution to vote on. Trustee Vinnedge discussed the temporary enclosures we did on the towers. He spoke with Kevin Propst, and he did enclosures on a tower in Leaf River. Trustee Vinnedge passed around a picture of that enclosure. Kevin gave a quote of \$1200 for both towers. The board is in agreement to have him do the work.
